

# Privacy policy

## What kind of information do we collect from website visitors, and how do we use it?

You don't have to give any personal or private information about yourself when you visit our website. We collect personal information about you only when you specifically and knowingly give it to us, for example by filling out an online form. We will use the personal information you give us:

- For the reasons stated when you provide it, for example to contact you about content you have sent us for the website, or to reply to your questions or comments. If you contact us, we may keep a record of that correspondence.
- To send you emails about our work or about new developments in the migration sector - for example our e-bulletin.

Except as set out in this privacy policy, in general we will not share any personal information collected on this website with any third party unless we have your consent, or unless we believe that we are required by law to do so.

We collect website usage information to help us understand how many people visit the website, how the website is used and whether there have been any technical problems. This information is collected anonymously, without identifying individual visitors.

## Cookies

We use cookies on this website. By using our website, you are consenting to the placing of certain types of cookies on your computer.

## Photos, videos, and sound recordings

We use the internet and publications to communicate with organisations and with the public. Through our social media accounts and website, we post photos, videos, and sound recordings of our work and events, which may sometimes include personal data. Although we try to seek consent, this may not always be possible when capturing large groups, big events, crowds or public street scenes.
