Change of conditions to access to public funds applications 申請改變居留條件

You can apply for a change to your conditions if:

- your financial circumstances have changed since being given permission to stay in the UK and you are no longer able to provide food or housing for yourself or your family
- there are reasons relating to a child's welfare which mean you need access to public funds
- you are facing exceptional circumstances affecting your income or expenditure

如有以下情況，你可以申請改變居留條件：

- 自從獲批准居留英國後，你的財政狀況出現變化，以致未能負擔你或你家人的食物或房屋支出
- 你孩子的福利受到影響而需要獲得公共資金
- 你正面臨特殊情況而影響你的收入或支出

You'll qualify for an amendment to your conditions of leave only if:

- You're destitute or at risk of destitution
- There are particularly compelling reasons relating to the welfare of your child on account of your very low income
- There are exceptional circumstances in your case relating to your financial circumstances

A person is destitute if:

- They do not have adequate accommodation or any means of obtaining it (whether or not their other essential living needs are met)
- They have adequate accommodation or the means of obtaining it, but cannot meet their other essential living needs
- They are at risk of destitution if either or both of the above are imminent

你須符合以下情況，才可申請改變居留條件：

- 你十分窮困潦倒 (赤貧)，或你面臨窮困潦倒 (赤貧) 的風險
- 基於特殊而有力的理由，你的極低收入會影響到孩子的福利
- 你的財政狀況出現特殊情況

窮困潦倒 (赤貧) 即：

- 沒有適當的住所或沒有任何獲得住所的方法 (無論其他基本生活需求是否得到滿足)
- 有足夠的住房或獲得住所安排，但不能滿足其他基本生活需求
- 如果上述任何一種或兩種情況即將發生，他們就有可能已陷入貧困

If you successfully apply for a change of conditions whilst you have a BNO visa, it will not impact your ability to apply for settlement through the BNO route after 5 years of living in the UK.

如你成功申請改變居留條件，這不會影響到你在英國居住 5 年後透過英國國民(海外)簽證來申請永久居留。

To make the request for an amendment to the conditions of your leave you must:

- Complete your application online
- Provide your passport and the proof of your immigration status
- Provide documentary evidence that you meet the policy granting recourse to public funds
- You will need to explain what your current financial circumstances are, how these may have changed, and how you're currently maintaining yourself

Documents required :

1. 6 months bank statements for all accounts held by all members of your household, even those belonging to children or ones that are rarely used - these should include an explanation of any significant and/or regular transactions
2. recent pay slips accounting for the last 6 months
3. breakdown of monthly income and expenditure
4. recent tenancy agreement or mortgage statement
5. recent utility and other relevant bills
6. recent P45 / P60

要申請改變居留條件，你必須：

- 提交網上申請
- 提供你的護照以及入境身份證明
- 提供文件證明你符合相關政策的申請資格
- 你需要解釋你目前的財務狀況發生了什麼變化，以及你目前是如何維持生活

所需文件

1. 6個月銀行月結帳單，包括所有家庭成員持有的所有帳戶，甚至是屬於孩子的帳戶或很少使用的帳戶 - 月結單應該有完整的註釋，以降釋重大/定期交易
2. 過去 6 個月的糧單
3. 每月收入及支出明細
4. 最近的租約或抵押貸款文件
5. 最近的水電費和其他相關帳單
6. 最近的 P45 / P60

Documents required:

7. letter confirming duration of employment, hours worked and salary (the person writing should state their position in the company and provide contact details)
8. recent letter from a local authority confirming that support is being provided
9. recent letter from registered charity or other organisation providing support
10. recent letters from family or friends who are providing support, giving full details regarding the extent of this and how often it is provided
11. recent letter confirming that you or your spouse or partner is in receipt of public funds, if available

If your request is successful

Your conditions of stay will be amended to allow you to receive public funds.

Timeframe for assessing the request

No service standards apply to the assessment of whether the applicant qualifies for a change of condition code, but caseworkers will make reasonable efforts to decide such requests promptly, especially those involving a child or an applicant who is street homeless, disabled or otherwise in vulnerable circumstances.

所需文件

7. 確認就業年期、工作時間和薪金的信件（寫信人應說明其在公司的職位並提供詳細的聯繫方式）
8. 地方當局最近發出的信件，以確認申請人現正接受的援助
9. 註冊慈善機構或其他提供支援的組織的近期信件
10. 提供支援的家人或朋友的近期信件，詳細列明其支援程度及頻率
11. 證實你或你的配偶或伴侶正在接受公共福利的近期信件（如適用）

如果你的申請成功

你的居留條件將被修改，以允許你接受公共福利

審批申請時間

審批時間沒有既定標準，但相關部門會在合理時間內盡快審批，特別涉及兒童或無家可歸、殘疾或處於其他弱勢情況的申請。
